## 6. ADMINISTRATIVE POLICIES



### GENERAL SUMMER CAMP ADMINISTRATIVE POLICIES

- Our summer camp refund policy:
  - Any date changes to your original camp registration can be made until June 1, 2019 Space permitting All requests must be made in writing.
  - We offer house credit only for cancelled summer camp weeks, until June 1, 2019 . No refunds.
  - No house credit or refund for any cancelled camp registration after June 1, 2019
- Minimum registration requirements
  - Junior and Senior Camp: 5 days (Campers 5th grade and younger)
  - LIT: 5 days (Middle School Campers )
  - Jr. Counselor: 15 days (High School Campers )
- If your camper requires additional support beyond our normal staffing ratios; an additional fee may be required.
- Campers who leave the program due to behavioral reasons will not receive refunds for unused camp days.
- Make ups for missed camp days are not available. If you are unable to attend camp due to due to illness or family emergency , we offer a voucher for Saturday Nite Mini Camp redeemable during the 2019/2020 school year.
- The completed registration form must be received to reserve camp days. We regret we cannot take reservations over the phone. If you are unable to register in person, registration forms can be faxed to 642-9211 or emailed to [summer@brentwoodcommons.com](mailto:summer@brentwoodcommons.com).
- Health forms must be received by June 1, 2019.
  - **Your child will not be allowed participate in camp if the health form is missing or incomplete.**
  - Refunds will not be made for those missing camp due to lack of necessary paper work. Please make arrangements for this well in advance, as the medical must be signed by the child's physician.
  - All completed medicals must contain the following information:
    - ~Child's Heath History
    - ~Statement of Health Status
    - ~Immunization History
- For campers requiring an epi-pen, inhalers or prescription, or OTC medication we require a Medication Consent Form.** This form is available on our website [www.summeratbrentwoodcommons.com](http://www.summeratbrentwoodcommons.com).
  - We also require a FARE form if applicable. (Food Allergy and Anaphylaxis Emergency Care Plan)
- We make every possible effort to provide the daily swim lesson and free swim time, however, if swimming must be cancelled due to unsafe conditions we do not provide a make-up.
- The camp day ends at 4:30. Early pick ups are disruptive to end of the day programming for all campers. For this reason, if you must pick up your child early, please arrange to pick-up by 3:30. In consideration of all our campers, no early pick ups will be allowed between 3:30 and 4:30pm
- Extended care begins at 7:15 and ends at 6:00. Must be prearranged. Please call the office to enroll in extended care.
- If someone other than a parent will be picking up your child you MUST notify summer camp staff in writing at camp drop off.
